Non-Profit Symposium for the Benefit of Orange County Planned

As with most rural communities, Orange County faces many obstacles. And while there are many organizations and agencies addressing those problems in our community, most of them are facing obstacles of their own—shortages of manpower, decreased funding, and a lack of public awareness, to name a few.

In an effort to face head-on the problems plaguing Orange County's benevolent and philanthropic organizations and agencies, the Orange County Community Foundation is hosting a non-profit symposium for the benefit of Orange County. The event will bring together representatives from numerous concerned entities and give them a chance to discuss the challenges in Orange County, in an effort to join forces in meeting those challenges with combined resources and creativity.

Speakers and facilitators will be on hand to provide information and inspiration regarding such topics as fund-raising, public relations and communications, and effective collaborations. A workshop in marketing is planned, as well as a

panel discussion regarding fund development. Highlight of the day will be roundtable discussions, in which participants can choose from a number of topics and take part in discussions of those topics with members of other organizations which deal with the same challenges.

Topics for roundtable discussions include health and human services, education, issues facing children and families, economic issues, and the problem of illiteracy.

The symposium, and all-day event, will take place Wednesday, November 5, at the French Lick Resort Casino. Cost is \$25 per participant, and includes breakfast, lunch and all materials necessary.

Patricia Clements has been elected to serve as the Foundation's vice president. She

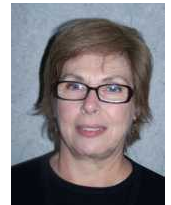
has been a member of the OCCF Board since inception, and has previously served as chairperson for Women in Philanthropy.
